### Description

The DCMA Internship Program places you in a specific DCMA office based on your academic background, interests, and security clearance eligibility. You'll work on real-world projects under the guidance of experienced mentors in areas like:

- **Industrial Security:** Support efforts to ensure the security of the defense supply chain and protect sensitive information within contractor facilities.
- **Counterintelligence:** Contribute to initiatives that identify and counter foreign espionage activities that threaten U.S. security.
- **Security Technologies:** Explore the latest technologies used in counterintelligence, security assessments, and information security.
- **Policy & Analysis:** Assist with research and analysis to support the development and implementation of effective security policies.

- Minimum GPA of 3.0 required (requirement may vary).
- Strong interest in national security, counterintelligence, and security practices.
- Ability to obtain a security clearance (security clearance level will vary depending on the internship).

- Prior internship or relevant work experience in security, government, or a related field is preferred, but not required.
